PREFACE

The Guam Law Library was established pursuant to Guam Public Law 14-155 (1978). It is a tax-exempt non-profit educational corporation. It is the largest and most complete legal research center in Guam serving the entire Western Pacific Community. The Board of Trustees is appointed by the Governor, the Legislature, the Judiciary and the Guam Bar Association. The Library is open to the public and is funded primarily through filing fees and fines paid to the Courts.

The collection of the Guam Law Library contains over 30,000 volumes in paper format. It also includes over 5,000 volume equivalents in microformat.

The library serves as a depository for decisions of the Superior Court and the Supreme Court. All Public Laws, Executive Orders and Legislative materials are also deposited with the library and are available for public use and copying.

In addition to a core holding of U.S. law (national reporter system, federal, digests, encyclopedias, treatises, etc.) the library maintains extensive legal materials for Guam and other Pacific Island jurisdictions. This bibliography attempts to list most of these materials. All of these materials are available for use in the library or copies may be available through the library's search and copy service or through inter-library loan.
