In light of the Governor's and Chief Justice's orders limiting governmental and judicial operations, the Guam Law Library will **reopen to the public on Wednesday, May 6, 2020.**

However, keys are limited, and requests for immediate access cannot be accommodated. Please visit <http://guamlawlibrary.org/faqs/> to view the After-Hours Access Policy. Note that after-hours access is for GBA members only, not clients.

GBA members are not permitted after-hours access if any of the conditions exist:

- You have been diagnosed with, or have or had contact with, anyone who has been diagnosed with COVID-19;
- You have acute respiratory illness symptoms (i.e. cough, shortness of breath, headaches), flu-like symptoms, fever, coughing, or sneezing;
- You have been asked to self-quarantine by any physician, hospital, board of health, or other medical provider or health agency; or you reside with anyone who has been asked to self-quarantine;
- You have, within the last 14 days, traveled outside of Guam; or
- You reside with, or have had close contact with, a person who has traveled outside of Guam within the last 14 days.

**We encourage you to contact us by phone or email.** The library and Compiler's Office staff are ready to respond to your inquiries, despite the limitation on our operations imposed by the current public health emergency.
