Annual CLE requirement

Active GBA members must complete 10 CLE hours, of which 2 hours must be in legal ethics and/or professionalism. CLE for 2012 must be completed by December 31, 2012, and certified to the GBA office by January 31, 2013. (Supreme Ct. Prom. Order 11-004-01)



CLE Materials Loan Policy

Beginning December 1, 2012, the Guam Law Library will implement a new policy for circulation of CLE materials. The new policy establishes regular loan periods and item limits for January to November. It also establishes special terms during the month of December:

- **Item limit:** Eligible borrowers may sign out up to two (2) CLE programs at any one time. Authorized borrowers picking up on behalf of law firm attorneys are limited to only four (4) items at any one time.
- **Loan period:** CLE programs may be borrowed for two (2) calendar days. Items borrowed on Fridays are due by 12 noon the following Monday.
- **Reserved items:** Reserved items must be checked out by COB on the day the Law Library gives notice to the borrower that the items are available, or they will be circulated immediately.
- **Renewals:** Renewals are not permitted in December.
