

Further issues discussed include advising clients to remove Faebook photos, adjusting Facebook privacy settings, websites as communications, guarantees, warranties and predictions, LinkedIn as advertising, disclaimers, hard VS. soft third party testimonials, threatening criminal action, discussing client cases with other attorneys and family members, conflicts of interest with current clients, email and privilege, ethically storing client data in the cloud and reasonable precautions.

Honesty is Best Policy: How Far Can You Go in Negotiations, 1.0 Legal Ethics

As attorneys we are taught to zealously defend our clients. However, in some instances there is a fine line between zealously defending your client and crossing ethical boundaries.

In this presentation, attorney David Cameron Carr discusses the ethical considerations of an attorney's duties toward clients and third parties in negotiation, using "means consistent with truth" when dealing with courts and the ethics of mediation. Further topics addressed include the duty of honesty, the applicable discipline standard for dishonest conduct, ABA Model Rule 4.1 'Truthfulness In Statements To Others,' the Trial Conduct Rule and reconciling Candor to the Court v. the Duty of Confidentiality.

Selected Issues in Legal Ethics, 1.0 Legal Ethics

Join Professor Steve Berenson for a comprehensive review of selected ethics issues that you face in your everyday practice.
